RBI issues draft guidelines for establishing self-regulatory organizations

-The Reserve Bank of India (RBI) issued draft guidelines for establishing selfregulatory organizations (SROs), which will be responsible for framing and enforcing rules for payment systems operators.

-An SRO as per RBI will be a nongovernmental organization that sets and enforces rules and standards relating to the conduct of entities in the industry. These will collaborate with all stakeholders in framing rules and regulations, and their self-regulatory processes will be administered through impartial mechanisms.

The NUE could choose to be a for-profit entity or a not-for-profit as defined under Section 8 of the Companies Act. The systems that it develops will be expected to interact and be interoperable, to the

extent possible, with the systems operated by NPCI.
